Terms & Definitions

Management system?

A management system is the way in which an organization manages the inter-related parts of its business in order to achieve its objectives. These objectives can relate to a number of different topics, including product or service quality, operational efficiency, environmental performance, health and safety in the workplace and many more.

ISO model: agreed by experts

ISO management system standards (MSS) help organizations improve their performance by specifying repeatable steps that organizations consciously implement to achieve their goals and objectives, and to create an organizational culture that reflexively engages in a continuous cycle of self-evaluation, correction and improvement of operations and processes through heightened employee awareness and management leadership and commitment. MSS are the result of consensus among international experts with expertise in global management, leadership strategies, and efficient and effective processes and practices. MSS standards can be implemented by any organization, large or small.

Audits

Audits are a vital part of the management system approach as they enable the company or organization to check how far their achievements meet their objectives and show conformity to the standard. In order to help the auditing related to these standards, ISO has released ISO 19011:2015 providing specific guidance on internal and external management system audits.

Certification

Certification to management system standards is **not** a requirement. You can benefit from implementing these standards without being certified to them. However, if you are looking to get certified to one or more of our management system standards, then you need to get in touch with an external certification body.

Keeping it simple

Many ISO management system standards have the same structure ANNEX SL and contain many of the same terms and definitions. This is particularly useful for those organizations that choose to operate a single (sometimes called “integrated”) management system that can meet the requirements of two or more management system standards simultaneously.
